AUDIENCE QUESTION AND COMMENT ON AGENDA ITEMS 33 34 Audience members commented on the budget, the potential increase in assessments, reserves, 35 decisions made by the Board in the past, pool construction, contingency funds, and how surplus funds were utilized. 36 37 38 39 4. BUSINESS ITEMS 40 41 i. Consideration of Resolution 2017-02; Approving Proposed Fiscal Year 2018 42 **Budget & Setting Public Hearing** 43 44 The Board and staff reviewed the budget presented. The budget presented represented service 45 levels and improvements completed in prior years, along with funding to cover the operations of

the new pool and funding the Reserves 100% according to the Reserve study.

46 47 The Board reviewed the budget and decided there were line items that could be reduced to bring the assessment increase down; they decided that capital improvements and enhancements would be tabled. The Board also decided that the District would look to maintain the assets it currently has and not fund the Reserves this year, but look to contribute to Reserve funding in a future budget. The BOS reviewed a 15% increase and what the general impact that would have on the different lot sizes. The Board directed staff to scrub the budget to look for more savings and to scale back expenditures.

The Board then went over this history of the District and how the surplus funds were spent. They explained that there had not been an increase in Rivercrest for 8 years, which was a very good track record compared to other districts. The Board also discussed putting in measures to control spending overall. The Board let the audience speak again on the budget, and comments were made about surplus funds, pocket parks, whether the Reserves should be funded now, whether the pool should have been built if it meant increasing fees, along with other topics covered in prior comments.
