The Special Meeting of the Board of Supervisors for Rivercrest Community Development District was held on **Monday, June 1, 2017 at 6:30 p.m.** at the Rivercrest Clubhouse, located at 11560 Ramble Creek Drive, Riverview, Florida 33569.

1. CALL TO ORDER/ROLL CALL

Brian Howell called the Special Meeting and of the Board of Supervisors of the Rivercrest Community Development District to order on **Monday, June 1, 2017 at 6:30 p.m.**

Brian Howell led the Pledge of Allegiance.

3. AUDIENCE QUESTION AND COMMENT ON AGENDA ITEMS

Audience members commented on the budget, the potential increase in assessments, reserves, decisions made by the Board in the past, pool construction, contingency funds, and how surplus funds were utilized.

4. BUSINESS ITEMS

i. Consideration of Resolution 2017-02; Approving Proposed Fiscal Year 2018 Budget & Setting Public Hearing

The Board and staff reviewed the budget presented. The budget presented represented service levels and improvements completed in prior years, along with funding to cover the operations of the new pool and funding the Reserves 100% according to the Reserve study.

48 The Board reviewed the budget and decided there were line items that could be reduced to bring
49 the assessment increase down; they decided that capital improvements and enhancements would
50 be tabled. The Board also decided that the District would look to maintain the assets it currently
51 has and not fund the Reserves this year, but look to contribute to Reserve funding in a future
52 budget. The BOS reviewed a 15% increase and what the general impact that would have on the
53 different lot sizes. The Board directed staff to scrub the budget to look for more savings and to
54 scale back expenditures.

56 The Board then went over this history of the District and how the surplus funds were spent. They
57 explained that there had not been an increase in Rivercrest for 8 years, which was a very good
58 track record compared to other districts. The Board also discussed putting in measures to control
59 spending overall. The Board let the audience speak again on the budget, and comments were
60 made about surplus funds, pocket parks, whether the Reserves should be funded now, whether
61 the pool should have been built if it meant increasing fees, along with other topics covered in
62 prior comments.

64 The Board discussed whether or not to accept payment for today's meeting.

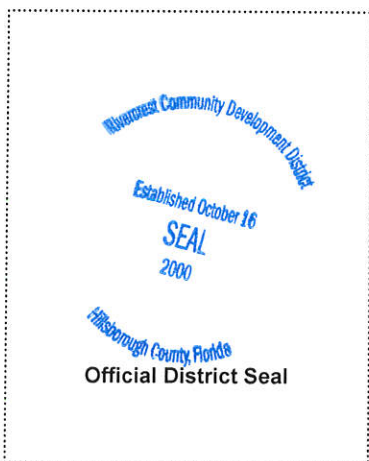
